- 3) As work is completed, subcontractors will invoice the prime and be paid by the prime within 10 days of their approved and accepted work.
- 4) This payment method applies to projects that use alternative delivery methods such as Design Build, Construction Manager at Risk, Job Order Contract, and Competitive Sealed Proposals.

The second program, Mobilization Prompt Pay Program (MPP), allows for bi-monthly payments to the subcontractors at the beginning of a project. The procedure is outlined as follows:

- 1) The prime contractor submits pay applications twice a month, rather than monthly, at critical mobilization points usually during the first few months of work.
- 2) Subcontractors added at a later point in a project will have flexibility to submit invoices to cover the critical period of the project.
  - 3) This payment method applies to projects valued at over \$2 millions.

In the meantime, the independent loan program involves the city approaching 3rd party financial institutions to offer loans with less stringent criteria than traditional commercial loans.

This program, still in its embryotic stage, will need time to develop since it relies on voluntary participation by banks or credit unions. It is yet unknown how lenient the approval rates and what the interest rates will be over the terms of the loans.

The city does not endorse one financial institution over an-

other. It has no authority or leverage in the negotiation of terms on behalf of the subcontractors; therefore it is entirely incumbent upon the subcontractors to shop for the best loans themselves.

## **New Quick Pay and Prompt Pay Programs to Roll Out in 2015**

Austin—The city will begin two new payment programs next year that will allow subcontractors on city projects to receive payment before and soon after their work is completed.

These programs have come to being following indefatigable recommendations from Carol Hadnot, Program Manager of the Austin Area Black Contractors Association, and general concerns over the city's new living wage policy from the business community. City subcontractors often found themselves financially strapped by the up-front costs to work on major city projects and the 45 to 60 days of payment process time from the city to flow down to the subs. They also worry that their small to medium sized companies will have to resort to more expensive financing to pay for higher wages.

After a series of stakeholders meetings, City Council's MBE/WBE and Small Business Committee adopted the two payment programs and an independent loan program presented by city staff in January of 2014.

The first program to be implemented, Quick Pay Program (QP), will give subcontractors direct access to funds after their work is completed, rather than waiting for the prime to get paid first. The procedure is outlined in a SMBR memo as follows:

- The prime contractor will invoice the city for QP funds at the beginning of a project.
- Subcontractors interested in participating in the process

The City of Austin's Small & Minority Business Resources Department (SMBR) is requesting public comment on the proposed Airport Concession Disadvantaged Business Enterprise (ACDBE) Program Plan for Fiscal Years 2015-2017. The anticipated goals are 14.72% for Non-Car Rental Concessions and 2.43% for Car Rental Concessions, as measured by estimated annual gross receipts.

# Trammell Crow Company, Principal Real Estate Investors and City of Austin Complete Transaction on Second Phase of Green Water Treatment Plant

Trammell Crow Company and joint venture partner Principal Real Estate Investors are pleased to announce the acquisition of the Green Water Treatment Plant (GWTP) parcel known as 500 W. 2<sup>nd</sup> Street in downtown Austin from the City of Austin.

Construction is scheduled to begin immediately on the 500,436 square foot project, which will feature 489,403 square feet of Class A speculative office space and 11,033 square feet of ground floor restaurant/retail space.

The building is scheduled to be complete by 1Q 2017. 500 W. 2<sup>nd</sup> Street is the second of four parcels to be developed by Trammell Crow Company as part of its partnership with the Cityof Austin to bring new vibrancy and land uses to downtown Austin and the emerging Seaholm Development District.

### **CAMPO Board OKs List of Future Transit Projects**

The Capital Area Metropolitan Planning Organization Transportation Policy Board approved a recommended list of regional transit projects Monday, including a commuter rail line from Elgin to Austin and multiple new MetroRapid Bus routes, to prioritize for potential funding under its draft long-range plan.

The board also approved a recommended list of roadway projects in Travis, Hays, Caldwell, Williamson and Bastrop Counties to potentially fund with \$605 million in remaining federal and state dollars.

## City of Austin Announces New Public Art Opportunity at Austin Shelter for Women and Children

Art in Public Places (AIPP), a program of the City of Austin's Cultural Arts Division of the Economic Development Department, seeks to commission a professional artist, or artist team, to create artwork for the Austin Shelter for Women and Children (ASWC) located at 4523 Tannehill Lane in East Austin.

Visual artists who live or work in Texas are eligible to apply. The total budget for this project is \$68,000. The application deadline is 5:00 pm, January 8, 2015.

## Applications Open for Free Environmental Site Assessments

A grant from the Environmental Protection Agency will provide funding for site assessments of brownfields making it more affordable to transform underutilized land into beneficial community developments. Environmental site assessments are the first step towards revitalizing communities, growing Austin's economy and protecting the environment and public health.

Austin Resource Recovery's Brownfields Program recently received \$400,000 from the EPA to provide environmental assessments and cleanup planning to assist with property transactions for site redevelopments. Qualified applicants can apply now for free environmental site assessments.
